

MINUTES of a rescheduled regular public meeting of the Board of Park Commissioners of the Frankfort Square Park District, Will and Cook Counties, Illinois, held at the Park District Administration Building, 7540 West Braemar Lane, Frankfort, Illinois, in said Park District at 7:30 o'clock P.M., on the 23rd day of October, 2014.

The President called the meeting to order and directed the Secretary to call the roll.

Upon the roll being called, Ken Blackburn, the President, and the following Park Commissioners were physically present at said location: _____

The following Park Commissioners were allowed by a majority of the members of the Board of Park Commissioners in accordance with and to the extent allowed by rules adopted by the Board of Park Commissioners to attend the meeting by video or audio conference: _____

No Park Commissioner requested to attend the meeting by video or audio conference.

The following Park Commissioners were absent and did not participate in the meeting in any manner or to any extent whatsoever: _____

The President announced that the Board of Park Commissioners would consider the adoption of an ordinance abating the tax levied for the year 2014 to pay the principal of and interest on the District's outstanding alternate bonds.

Whereupon Park Secretary Jim Randall presented read by title an ordinance as follows, a copy of which was provided to each Park Commissioner prior to said meeting and to everyone in attendance at said meeting who requested a copy:

ORDINANCE NO. 14-10-283

ORDINANCE abating the tax hereto levied for the year 2014 to pay the principal of and interest on General Obligation Refunding Park Bonds (Alternate Revenue Source), Series 2013, General Obligation Park Bonds (Alternate Revenue Source), Series 2010, General Obligation Park Bonds (Alternate Revenue Source), Series 2009, and General Obligation Park Bonds (Alternate Revenue Source), Series 2002, of the Frankfort Square Park District, Will and Cook Counties, Illinois.

WHEREAS the Board of Park Commissioners (the “*Board*”) of the Frankfort Square Park District, Will and Cook Counties, Illinois (the “*District*”), by Ordinance Number 13-02-267, adopted on the 21st day of February, 2013, Ordinance Number 10-06-239, adopted on the 17th day of June, 2010, Ordinance Number 09-04-222, adopted on the 27th day of April, 2009, and Ordinance Number 02-00-150, adopted on the 4th day of September, 2002 (each, a “*Bond Ordinance*”), did provide for the issue of \$485,000 General Obligation Refunding Park Bonds (Alternate Revenue Source), Series 2013, \$1,870,000 General Obligation Park Bonds (Alternate Revenue Source), Series 2010, \$1,200,000 General Obligation Park Bonds (Alternate Revenue Source), Series 2009, and \$750,000 General Obligation Park Bonds (Alternate Revenue Source), Series 2002, of the District, respectively (collectively, the “*Bonds*”), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS the District hereby determines that the Pledged Revenues (as defined in each Bond Ordinance) are or will be available to pay the principal of and interest on the respective series of Bonds when due in the next succeeding bond year so as to enable the abatement of the Pledged Taxes (as defined in each Bond Ordinance) levied for the same; and

WHEREAS the Pledged Revenues are hereby directed to be deposited to the respective Bond Fund (as defined in each Bond Ordinance) and used for the purpose of paying the principal of and interest on the respective series of Bonds due in the next succeeding bond year; and

WHEREAS it is necessary and in the best interests of the District that the tax heretofore levied for the year 2014 to pay the principal of and interest on each respective series of Bonds be abated;

NOW THEREFORE Be It Ordained by the Board of Park Commissioners of the Frankfort Square Park District, Will and Cook Counties, Illinois, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true and correct and does incorporate them into this Ordinance by this reference.

Section 2. Abatement of Tax. The tax heretofore levied for the year 2014 in each Bond Ordinance is hereby abated in its entirety.

Section 3. Filing of Ordinance. Forthwith upon the adoption of this Ordinance, the Secretary of the Board shall file a certified copy hereof with the County Clerks of The Counties of Will and Cook, Illinois, and it shall be the duty of said County Clerks to abate said tax levied for the year 2014 in accordance with the provisions hereof.

Section 4. Effective Date. All ordinances, resolutions or parts thereof in conflict herewith be and the same are hereby repealed and that this Ordinance shall be in full force and effect forthwith upon its adoption.
