The President announced that the next item of business before the Board of Park Commissioners was the consideration of an ordinance abating the taxes heretofore levied for the years 2016 to 2019, inclusive, to pay the principal of and interest on the General Obligation Park Bonds (Alternate Revenue Source), Series 2002, of the District. Whereupon Park Commissioner \_\_\_\_\_\_ presented and the Secretary read by title an ordinance as follows, a copy of which was provided to each Park Commissioner prior to said meeting and to everyone in attendance at said meeting who requested a copy:

## **ORDINANCE NO. 16-06-295**

AN ORDINANCE abating the taxes heretofore levied for the years 2016 to 2019, inclusive, to pay the principal of and interest on the General Obligation Park Bonds (Alternate Revenue Source), Series 2002, of the Frankfort Square Park District, Will and Cook Counties, Illinois.

WHEREAS, the Board of Park Commissioners (the "*Board*") of the Frankfort Square Park District, Will and Cook Counties, Illinois (the "*District*"), by Ordinance Number 02-00-150, adopted on the 4th day of September, 2002 (the "*Bond Ordinance*"), did provide for the issue of \$750,000 General Obligation Park Bonds (Alternate Revenue Source), Series 2002, dated September 1, 2002 (the "*Bonds*"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS, on the 22nd day of September, 2004, the Board adopted Ordinance No. 04-09-172, authorizing and directing the redemption of \$370,000 in aggregate principal amount of the Bonds, and further authorizing and directing that a portion of the taxes heretofore levied for the years 2004 to 2019, inclusive, to pay the Bonds be abated; and

WHEREAS, it has recently come to the Board's attention that such direction for abatement of taxes was never filed with the County Clerks of The Counties of Will and Cook, Illinois (the *"County Clerks"*); and

WHEREAS, the Board at this time desires to correct such omission and direct the County Clerks to abate all of the taxes heretofore levied for the Bonds as all of the then remaining Bonds were optionally redeemed by the District on July 1, 2011, and are no longer outstanding:

NOW, THEREFORE, Be It and It is Hereby Ordained by the Board of Park Commissioners of the Frankfort Square Park District, Will and Cook Counties, Illinois, as follows:

*Section 1. Incorporation of Preambles.* The Board hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true and correct and does incorporate them into this Ordinance by this reference.

*Section 2. Abatement of Taxes.* The taxes heretofore levied for the years 2016 to 2019, inclusive, in the Bond Ordinance are hereby abated in their entirety.

*Section 3. Filing of Ordinance.* Forthwith upon the adoption of this Ordinance, the Secretary of the Board shall file a certified copy hereof with the County Clerks, and it shall be the duty of the County Clerks to abate said taxes levied for the years 2016 to 2019, inclusive, in accordance with the provisions hereof.

*Section 4. Effective Date.* All ordinances, resolutions or parts thereof in conflict herewith be and the same are hereby repealed and that this Ordinance shall be in full force and effect forthwith upon its adoption.
