

FRANKFORT SQUARE PARK DISTRICT

ORDINANCE NO. 17-06-306

WHEREAS, Frankfort Square Park District (Park District) owns certain personal property that is no longer necessary, useful, or in the best interests of the Park District; and

WHEREAS, the disposal of Park District property is governed by the Park District Code (Code) 70 ILCS 1205/1 et seq; and

WHEREAS, section 8-22 of the Code, 70 ILCS 1205/8-22, provides that the Park District Board of Commissioners, by vote of three-fifths majority, may authorize the conveyance or sale of property that is no longer necessary, useful, or in the best interests of the Park District in any manner they may designate; and

WHEREAS, the Park District Board of Commissioners finds that it is in the best interest of the Park District to dispose of certain maintenance vehicles and equipment;

THEREFORE BE IT ORDAINED by the Board of Commissioners of the Frankfort Square Park District that:

1. The personal property listed on Attachment A, which is hereby incorporated into and made part of this Ordinance, is no longer necessary, useful, or in the best interests of the Park District.
2. The Park District Executive Director is hereby authorized to sell said personal property to Kankakee Truck Equipment of Kankakee, Illinois for the total amount of \$44,000.
