RESIDENT INPUT SUMMARY Ed Reidy, Superintendent of Parks 9/20/18 to 10/16/18

Old Business

- 7/16 A Lake of the Glens resident called to thank us for re-paving the walking path, and also inquired about a gap between the new asphalt and the grass that was removed.
 - ➤ I left a message informing the caller that the project was ongoing and gaps would be addressed shortly.
 - Update: Filling of gaps has begun.
- 8/1 An Indian Boundary South resident's son called to ask about standing water behind his mother's fence. We discussed a drainage project the District has been planning for some time that will address the low wet area. I told him it would most likely be a late fall / early winter project.
 - ➤ No new updates on this matter.
- 8/6 An Island Prairie resident inquired about removing a dead tree in the park behind her neighbor's fence. I contacted the neighbor to determine ownership of the tree. I also contacted two homeowners located at Benton and Farmington, informing them that the District's contractor required easement access between their properties, and all were in agreement.
 - ➤ The District's contractor inspected the area and found it too wet to complete the removal. Park staff will monitor the site and the contractor will complete the project once the ground is sufficiently dry.
- 9/11 A LaPorte Meadows resident requested repairs to a split rail fence.
 - \triangleright 9/12 Repairs to the fence began.
 - \triangleright 9/25 The repairs were completed.

New Business

- 9/20 A resident asked that we schedule their annual 5 K Run at Union Creek for April, 2019.
 - ➤ I provided the date information to the front desk for inclusion on the master calendar, and recreation staff were also made aware of the event.
 - 9/24 Boy Scout Troop 237 requested assistance with their upcoming Scouting for Food drive
 - ➤ I left a voicemail informing them that the Park District will provide tables and chairs for their event.

- ➤ 10/9 Park District staff and Boy Scout Troop leaders met to touch base on the Scouting for Food drive, a request to include future Scouting plans in the District's brochure, and building usage for the upcoming year.
- 10/10 A Lighthouse Pointe resident called to discuss the native plants, litter, and algae in the pond. I informed him that the controlled burn by the pond could not be completed due to the Spiess Construction project and the installation of the erosion control blanket along the water's edge.
 - ➤ 10/11 Maintenance staff and I inspected the area and picked up litter. I rang the resident's bell to invite him on a walk & talk, however, he was not present so a note was left in his door.
- 10/13 A patron notified us about a broken board on the Island Prairie boardwalk.
 - > Staff immediately identified the location and placed orange safety cones to warn patrons of the issue.
 - ➤ 10/15 Staff removed and replaced two broken boards, conducted a full inspection of the boardwalk, and found no other issues.
