**A RESOLUTION ADOPTING A FREEDOM OF
INFORMATION ACT TRANSPARENCY POLICY**

WHEREAS, the Frankfort Square Park District, Cook County and Will County, Illinois (the "District") is an Illinois unit of local government organized and operating under the Illinois Park District Code, 70 ILCS 1205/1 et seq., as amended and supplemented; and

WHEREAS, the District is a public body subject to the provisions of the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq.; and

WHEREAS, the Board of Park Commissioner finds it to be in the best interest of the District to adopt a Freedom of Information Act Transparency Policy;

NOW, THEREFORE, BE IT RESOLVED by the Board of Park Commissioners of the Frankfort Square Park District, Cook and Will County, Illinois, as follows:

1. Recitals. The Board finds the foregoing recitals to represent a complete and accurate description of the purpose of this resolution and incorporates them as part of this resolution as though fully set forth herein.
2. Freedom of Information Act Transparency. The Board hereby adopts the Freedom of Information Act Transparency Policy attached hereto as **Exhibit A**, incorporated and made a part hereof as though fully set forth herein.

3. Conflicts. All prior resolutions or administrative directives in conflict with this resolution are hereby repealed to the extent of such conflict.

EXHIBIT A

FREEDOM OF INFORMATION ACT TRANSPARENCY POLICY

FREEDOM OF INFORMATION ACT TRANSPARENCY POLICY

I. Statement of Purpose:

The Frankfort Square Park District is a “public body” as that term is defined in the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq (“Act”). As such, the Park District is required to, upon submission of a written request, provide public inspection of documents and/or copies of such documents as may be required by that Act.

This policy is established to articulate the District’s policy goals regarding the publishing of information pertaining to requests for documents filed in accordance with the Act and the District’s responses to such requests.

II. Policy:

It is the policy of the Frankfort Square Park District that it will post on its website, following the receipt of a request for documents in accordance with the Illinois Freedom of Information Act, the following:

- a. A copy of the request.
- b. A copy of the District’s response(s) to the request.
- c. Information summarizing the amount of staff time expended and any other costs that may have been incurred in responding to the request.
