PROPOSAL CONDITIONS

#### WARRANTY & SERVICE:

Enclosed is a copy of the 4-Year Warranty offered to *Frankfort Square Links* by the Yamaha Golf-Car Company. Harris Golf Cars provides an authorized Yamaha Service Representative who will be responsible for all warranty and requested service work. A dedicated service technician is a real asset to your facility because of his availability, reputation and the number of satisfied customers Harris Golf Cars has in your area. All visits are provided per attached agreement.

#### GOLF COURSE FLEET MAINTENANCE RESPONSIBILITIES:

Note the enclosed statement of Warranty for the fleet of cars proposed for *Frankfort Square Links*. Electric car operation requires 19 PSI of Air Pressure in tires, utilize single-point Watering System to maintain water level in batteries, keep battery posts clean, tight and free of corrosion, and charge cars in 'Tow' Position. The EFI or Carbureted Gas Cars require yearly (Oil Change, Filter Change, New Spark Plug and Fuel Element blown out) and Clutch Belt Maintenance (Replacement every 2-3 Years). Please keep in mind that failing to perform routine golf car fleet maintenance could void warranty coverage on resulting damage. Your cooperation is greatly appreciated.

#### EARLY ROLL-OUT:

Upon entering into the last year of the lease with Yamaha Commercial Customer Finance, if all terms and conditions of the lease have been satisfactorily met, Yamaha Golf-Car Company will grant customer the option of rolling into a new fleet of Yamaha golf cars. The new agreement must be with Yamaha Commercial Customer Finance and will be subject to their credit approval. The new payment will be based upon current fleet condition, product pricing and interest rates at that time.

#### TRADES:

At the end of the Lease Term or time of Roll Out, all trades must be in normal operating condition at the time of the new car delivery. Any car not running or having any excess damage beyond normal wear and tear will be charged to *Frankfort Square Links*.

#### CONCLUSION:

This Proposal is valid for 30 days, includes delivery-setup and is subject to the credit approval of Yamaha Commercial Customer Finance. This Proposal is binding and constitutes the entire understanding and agreement among the parties hereto relative to the subject matter hereof and supersedes all prior agreements and understandings between the parties, whether oral or in writing. Either party has made no representations or promises to the other with respect to the subject matter of this agreement, except as set forth in this agreement.

All warranty repairs, modification campaigns, including parts and labor.

Bi-Weekly service visits including labor to inspect and repair vehicles to ensure safety and Customer Satisfaction.

Annual Service: Labor & Parts Cost for Complete inspection and repair of components including but not limited to: steering, suspension, brakes, acceleration, electrical, drive train, clutches, batteries, tires, etc. All cars will be returned to specs for safety and reliability. *SERVICE INCLUDES(12/1 – 3/1) WINTER STORAGE*.

#### **CUSTOMER RESPONSIBILITIES**

Perform daily pre-operation inspection.

Maintain all fluid levels and provide clean fuel and or proper battery charge. Clean, Secure & Store all Golf Cars. Cost of parts for repairs (except annual service) from normal wear, not covered under warranty. Damage repairs from accident, abuse, negligence or acts of God. #### DEFINITIONS

<u>Preventive Maintenance</u>: All preventive maintenance as written in the Genuine Yamaha Periodic Maintenance Chart (found in owners manual) including labor. **This contract requires the use of Genuine Harris/Yamaha Parts** 

<u>Warranty</u>: Any repairs made due to a manufacturer's defect during Yamaha's limited four-year warranty period. This includes all factory modification campaigns. All Parts will be supplied by Harris/Yamaha to maintain and support factory warranty This service will provide Yamaha fuel injected engine 20 year warranty.

**<u>Bi-Weekly Service</u>**: visits to inspect the vehicles to ensure safety and Customer Satisfaction. To perform. maintenance warranty repairs and or normal wear and tear repairs as requested or recommended

<u>Normal wear</u>: A part not covered under warranty that wears out or fails due to normal wear and tear, including tire/wheels. This does not include repairs caused by damage, abuse, or acts of God. Harris Golf Cars will complete those repairs at customers expense.

# FOUR-YEAR LIMITED WARRANTY FOR DRIVE<sup>2</sup> GOLF CAR

Yamaha Golf-Car Company hereby warrants that any new Yamaha DRIVE<sup>2</sup> Gas or DRIVE<sup>2</sup> Electric Fleet golf car purchased from Yamaha, or an Authorized Dealer or Distributor in the United States, will be free from defects in material and workmanship for FOUR years from date of purchase, subject to the stated limitations. DURING THE PERIOD OF WARRANTY, any authorized Yamaha golf car service technician, dealer, or distributor will, free of charge, repair or replace, at Yamaha's option, any part adjudged defective by Yamaha due to faulty workmanship or material from the factory. Parts used in warranty repairs will be warranted for the balance of the vehicle's warranty period. All parts replaced under warranty become property of Yamaha Golf-Car Company.

## **EXCLUSIONS** from this Warranty shall include any failures caused by:

- Abnormal strain, neglect, or abuse, including lack of proper maintenance, and use contrary to the Owner's/ Operator's Manual instructions.
- Accident or collision damage
- Installation of parts or accessories that are not original equipment
- Fading, rust, or deterioration due to exposure or ordinary wear and tear
- Modifications or alterations that affect the car's condition, operation, performance, or durability.
- Damage due to improper transportation
- Acts of God (i.e. lightning, hail damage, flooding, fire, etc.)



This Limited Warranty does not cover any parts replaced due to normal wear or routine maintenance, including oil and air filter elements, brake shoes, tire wear, spark plugs, starter and clutch drive belts. Any charges incurred in transporting a golf car or charger to and from an authorized Yamaha golf car dealer for service or in performing field service are also excluded from this warranty. Gasoline-powered golf car starting batteries on vehicles equipped with a golf course GPS device, or any other device with a parasitic current draw, unless the vehicle is equipped from the factory with an optional, deep cycle starting battery, are also excluded from this warranty.

# THE CUSTOMER'S RESPONSIBILITY under this warranty, shall be to:

- Operate and Maintain the golf car, personal transportation vehicle (PTV), or commercial (Utility) vehicle as specified in the appropriate Owner's/Operator's Manual, and
- Give notice to an authorized Yamaha golf car dealer/distributor of all apparent defects within ten (10) days of discovery, and make the car available at that time for inspection and repairs at the dealer's/distributor's place of business; and
- Transport the car to and from an authorized dealer or distributor for warranty service.

## WARRANTY TRANSFER:

Any transfer of warranty must take place within the first three years of the original in-service date of the vehicle. The vehicle must be re-registered by an authorized Yamaha Golf Car dealer within 30 days of transfer. A fee may be charged for the transfer of the warranty.

## **EMISSION CONTROL SYSTEM WARRANTY (USA only):**

Yamaha Golf-Car Company also warrants to the ultimate purchaser of each gas-powered golf car covered by the warranty that the product is designed, built, and equipped so as to conform at the time of sale with all U.S. emission standards applicable at the time of manufacture and that it is free from defects in materials and workmanship which would cause it not to meet these standards within the same time period described in THE PERIOD OF WARRANTY above, or a minimum of two years, whichever is longer. Failures other than those resulting from defects in material or workmanship which arise solely as a result of owner abuse and/or lack of proper maintenance are not covered by this warranty.

Yamaha Golf-Car Company makes no other warranty of any kind, expressed, or implied. All implied warranties of merchantability and fitness of merchantability and fitness for a particular purpose, which exceed the obligations and time limits stated in this warranty, are hereby disclaimed by Yamaha Golf-Car Company and excluded from this Warranty.

Some states do not allow limitations on how long implied warranty lasts, so the above limitation may not apply to you. Also excluded from this Warranty is any incidental or consequential damages including loss of use. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion may not apply to you. This Warranty gives you specific legal rights, and you may also have other rights, which vary from state to state.
