

ORDINANCE NO. 26-06-370

AN ORDINANCE ADOPTING A COMBINED ANNUAL BUDGET AND APPROPRIATING SUCH SUMS OF MONEY AS MAY BE DEEMED NECESSARY TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES OF THE FRANKFORT SQUARE PARK DISTRICT, COOK AND WILL COUNTIES, ILLINOIS, FOR THE FISCAL YEAR BEGINNING MAY 1, 2026, AND ENDING APRIL 30, 2027.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE FRANKFORT SQUARE PARK DISTRICT:

SECTION 1: The following is the annual budget and appropriation for the Frankfort Square Park District for the fiscal year beginning May 1, 2026, and ending April 30, 2027.

Section 2: As part of the annual budget, it is stated:

- (a) That the cash on hand at the beginning of the fiscal year is \$1,663,071.38.
- (b) That the estimated cash expected to be received during the fiscal year from all sources is \$7,416,190.00.
- (c) That the estimated expenditures contemplated for the fiscal year is \$7,470,733.00.
- (d) That the estimated cash expected to be on hand at the end of the fiscal year is \$1,608,528.38.
- (e) That the estimated amount of taxes to be received by the Frankfort Square Park District during the fiscal year is \$4,327.950.00.

Section 3: That the following sums of money in the total amount of \$8,347,992.65 or so much thereof as may be authorized by law and the same are hereby appropriated for the corporate and recreational purposes of the Frankfort Square Park District, as hereinafter specified for the fiscal year beginning May 1, 2026, and ending April 30, 2027.

Section 4: The receipts and revenues of the Frankfort Square Park District derived from sources other than taxation and not specifically appropriated shall constitute the General Fund and shall first be placed to the credit of such fund. All unexpended balances of the appropriations for the fiscal year ended April 30, 2027, and prior years, are hereby specifically reappropriated for the same

general purposes for which they were originally made and may be expended in making up any insufficiency of any other items provided in this appropriation ordinance, in making this appropriation in accordance with applicable law.

Section 5: This Ordinance is not intended or required to be in support of or in relation to any tax levy made by the Park District during this fiscal year or any other fiscal year.

Section 6: All ordinances or parts of ordinances conflicting with any of the provisions of this Ordinance are hereby modified or repealed to the extent of such conflict. If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of the remaining portion of such item or the remainder of this Ordinance. This Ordinance shall be in full force and effect immediately upon its passage and approval according to law. A certified copy of this Ordinance shall be filed with the County Clerks of Cook County and Will County, together with the certificate of the Chief Fiscal Officer of the Park District certifying revenues by source anticipated to be received by the Park District within thirty (30) days after its approval, as provided by law.
